**SMALL PART ULTRASONOGRAPHY (BACK REGION)**

*Real time, B mode, grey scale and color doppler sonography of the back region.*

**Findings:**

There is evidence of cystic lesion seen in lower lumbar region communicating with spinal canal, measuring about 2.7 x 2.5 x 2.4 cm with few septae and linear echoes within possibly neural elements. No significant internal vascularity seen on color doppler. Possibility of myelocele/ myelomeningocele needs to be considered.

Marginally increased interpeduncular distance is seen at this lumbar level.

Rest of the visualized lower spine grossly appears normal.

Rest of soft tissue and visualized muscles appear normal.

Overlying skin appears intact.

**SUGGESTED:** *Clicopathological and MRI correlation for further evaluation.*

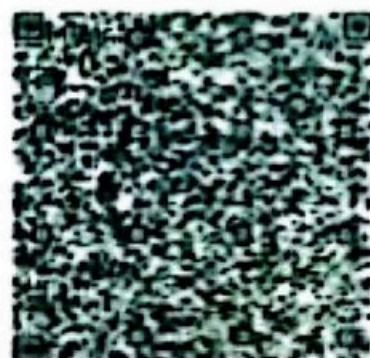
