## TO SPREADING BLISS FOUNDATION

This is to inform all concerned that Baby of Geetanjali(Male), DOB – 25-05-2026, is admitted in Jeevan Jyoti Hospital, Tikkampur – Sultanpur, Laksar Road, Distt. Haridwar, (Uttarakhand).

He is diagnosed **Spine Bifida with Myeleningocele &Gross Hydrocephalus.**

Treatment done so far- such as CBC, LFT KFT, PTINR, RBS, HCV, HIV, X-Ray Chest PA, MRI Brain suggested that can be undergo surgical investigation.

Treatment planned ahead –20-June-2026.

This baby will go for two surgeries which one is **Spina bifida** and second will be **Hydrocephalus.**

Duration of stay- icu/ward. Duration may vary depending on clinical condition and response to treatment.

Expected cost of treatment-4 Lakh

Prognosis- good/fair chances of survival/recovery if supported financially and outcomes have been good in previously managed similar cases.

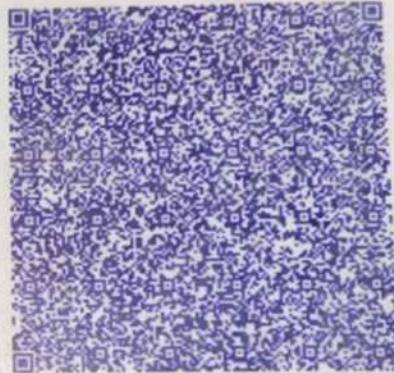




