Subject: Request for Financial Assistance for Critically ill Preterm Newborn

Greetings from SUYOG HOSPITAL, Nashik.

This is to certify that Baby of **MATHPATI VAIJANATH SAMBHAPPA - 2nd** (Male) a preterm, very low birth weight newborn has been admitted on 23/07/2026 to our Neonatal Intensive Care Unit (NICU) in a critical condition.

The baby was shifted to the NICU with severe bradycardia, cyanosis, and absent spontaneous breathing. Immediate resuscitation was performed, including endotracheal intubation, and Inj. Surfactant was administered due to severe respiratory distress. The baby is presently on mechanical ventilator support and requires continuous intensive monitoring and advanced neonatal care.

The newborn requires prolonged NICU management, including:

- \* Mechanical ventilator support
- \* Intensive neonatal monitoring
- \* Life-saving medicines and injections
- \* Laboratory and radiological investigations
- \* Specialized nursing care and supportive treatment

The baby's condition remains critical and life-threatening, and prolonged hospitalization is expected. The estimated cost of treatment is approximately ₹3,50,000 (Rupees Three Lakh Fifty Thousand only).

The family is financially unable to bear the expenses of this prolonged intensive treatment. We kindly request your foundation to extend financial assistance to help continue the baby's life-saving medical care.
