## TO SPREADING BLISS FOUNDATION

This is to inform all concerned that Neha Devi (Female), DOB – 24-6-2026, is admitted in Sethi Nursing Home, Daksh Mandir Road, Kankhal, Haridwar, Uttarakhand 249408.

She is diagnosed FT/EOS/MAS/Peumonitis.

Treatment done so far- such as CBC, LFT KFT, PTINR, RBS, HCV, HIV, X-Ray Chest PA.

Treatment planned is still in process.

Duration of stay in the NICU will be for 30-40 Days and Duration may vary depending on clinical condition and response to treatment.

Expected cost of treatment- 4 Lakhs

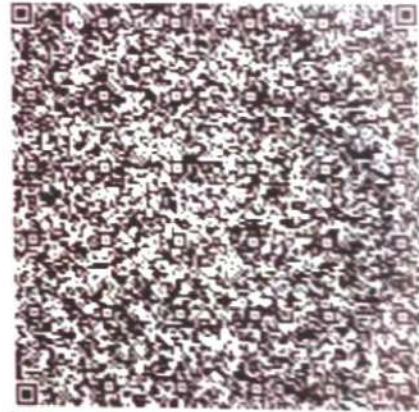
