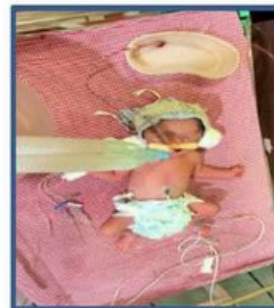

Subject: Serious Medical Treatment Estimate – Preterm Baby

Greetings from Suyog Hospital.

This is regarding **Baby of PAGAR DHANANJAY DADAJI, a 1.5 kg Male baby**, born preterm by emergency LSCS on 27/08/2026.

At birth, the baby was in a critical condition with no cry, no breathing, and no spontaneous respiration. The baby was immediately shifted to the NICU for emergency management and ventilator support was initiated. An NGT was also inserted for supportive care.

Considering the baby's prematurity and critical clinical condition, the baby requires:

- \* Continuous NICU care and monitoring
- \* Mechanical ventilation / respiratory support
- \* Necessary investigations and laboratory monitoring
- \* Medicines and supportive treatment
- \* Other emergency neonatal care as clinically required

Due to the critical condition and prematurity, the baby may require prolonged NICU management. The approximate total treatment cost is estimated up to ₹3,80,000/- (Rupees Three Lakh Eighty Thousand only), including NICU care, ventilation, investigations, medicines, and other supportive treatment.

This is a serious and critical neonatal case, and continued treatment is essential for the baby's survival and recovery.

We kindly request Spreading Bliss Foundation to consider providing financial assistance towards the baby's treatment expenses.
