TO SPREADING BLISS FOUNDATION

This is to inform all concerned that Baby of Rina (Male), DOB – 14-01-2026, is admitted in Sethi Nursing Home, Daksh Mandir Road, Kankhal, Haridwar, Uttarakhand 249408.

He is diagnosed Preterm/PDA/TTNB/RDS/LBW.

Treatment done so far- such as CBC, LFT KFT, PTINR, RBS, HCV, HIV, X-Ray Chest PA.


Treatment planned is still in process.

Duration of stay in the NICU will be for 60-70 Days and Duration may vary depending on clinical condition and response to treatment.

Expected cost of treatment- 5 Lakhs

Prognosis- good/fair chances of survival/recovery if supported financially and outcomes have been good in previously managed similar cases.

Urgent financial help is required for this patient.
