Subject: Appeal for Financial Assistance for NICU Treatment of **BABY OF BENDKOLI SACHIN NANA**

Respected Sir/Madam,

This is to inform you regarding Baby of BENDKOLI SACHIN NANA, Female baby, Date of Birth: 21/06/2026, delivered by Normal Vaginal Delivery Admitted in **NICU SUYOG HOSPITAL** in critical condition.

The Preterm baby 1.1 KG was admitted with Cyanosis with Apnea with very low birth weight. Due to worsening respiratory status, the baby required immediate intubation and ventilatory support. Inj Surfactant given.

Immediately 2D echo done

S/O :1) Large patent ductus arteriosus shunting bidirectionally predominantly right to left.
2)Small apical muscular ventricular septal defect shunting left to right.
3)Large ostium secundum atrial septal defect shunting left to right.

Considering the baby's critical condition and the possibility of prolonged NICU stay, the baby may require:

- * NICU admission and monitoring
- * Ventilator/CPAP support
- * Surfactant therapy
- * Intravenous fluids and medications
- * Antibiotics and inotropic support
- * Blood investigations and cultures
- * Radiological investigations
- * Specialist neonatal consultations

The approximate expenditure for treatment and hospitalization is ₹4,00,000/- (Rupees Four Lakhs Only). The final bill may vary depending on the baby's clinical course, duration of NICU stay, and additional interventions required.
