This is to inform you regarding MASTER MOHAMMAD ALTAMAS, a 2-year-old male patient, who was brought to our facility with complaints of developmental delays, specifically the inability to walk or stand. Difficulty in passing urine, pain while passing urine, bloody urine sometime, Upon thorough examination and investigation, Fever on and off and pallor and icterus and severe jaundice. It has been diagnosed that the child is suffering from **Cerebral Palsy and Acute Kidney Injury with Severe Jaundice** with significant involvement of the lower limbs.

Diagnosis:

- Cerebral Palsy with lower limb involvement
- Weakness of the lower limbs
- Acute kidney injury
- Severe Jaundice

Proposed Surgical Procedure:

- Right sided tendon of Achilles release with club foot correction
- Severe Jaundice

The estimated total cost for the surgery and associated treatment is **500000** (Five Lakh Rupees).

This estimate includes the following:

- Surgeon's fee
- Assistant's fees
- Anaesthesia charges
- Medication
- Hospital charges
- Investigations

Xray Equipment: GE 500 mA System, Konica Minolta Dry Pro 832 CR System.

Findings:

The lungs on the either side show equal translucency.

The pleural spaces are normal.

Hilar congestion is seen on both sides.

The heart and trachea are central in position.

No mediastinal abnormality is visible.

The cardiac size is normal.

The domes of the diaphragms are normal in position, and show smooth outline.

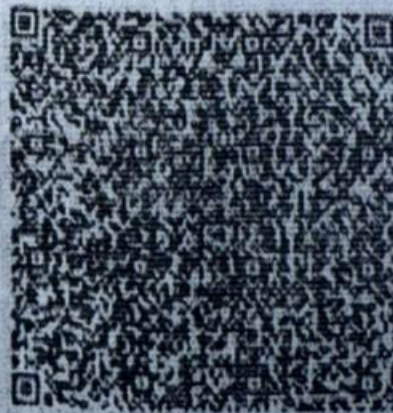

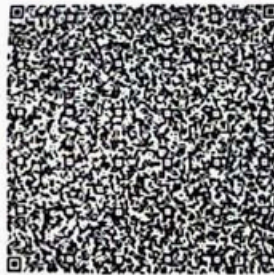
